In the background I got very involved in the Club's business and realised how much work is involved in running our Club. Therefore I thank the Committee from last year very much for their effort and time they put into running the Club.



Agreement that Constitution be amended as follows:

- 1. That Articles 7 and 9 include Vice President, Social Secretary and Editor.
- 2. That Article 6(a) be added to the Constitution and read as follows:
 "That the fee for a new membership be the same as for

renewals except that for new memberships received from the October general meeting only 50% of the rate shall apply "

- 3. That Article 13 of the Consitution be appropriately amended for a quorum of 25% for an Annual General Meeting, a quorum of 15% for a general meeting, and a quorum of 25% for motions relating to Articles 4, 7, 14, 17 and 18.
- . Committee was "empowered to purchase any photocopier to the maximum value of \$1000".
- . Club Person of the Year 1984/85 awarded to Bob Rumsey. Chris Fulker came second. Chris and Bob were given \$20 gift vouchers.

INCORPORATION STUDY REPORT

INTRODUCTION

This study was commenced following topical discussion and the consequent formation of the sub-committee in May 1984.

SUMMARY

Incorporation of the Club appears to have benefits which outweigh all the disbenefits. In particular, the individual members would not have to satisfy debts or liabilities incurred by the Club. They would also not be able to be sued personally and suffer the consequential loss of their personal or real property and assets. The Club would become a legally recognised non-profit organisation and be eligible to raise money or apply for loans and/or government grants.

LEGISLATION

The legislation controlling incorporation in the A.C.T. is the Associations Incorporation Ordinance 1953, and this is administered by the Corporate Affairs Commission (A.C.T.). The Ordinance is reasonably simple, involving only a relatively small number of mandatory requirements and fees.

The procedure for application to become incorporated, plus annual and other requirements are at Appendix A. It is worth noting that an acceptable Constitution must be lodged with the Commission. This will necessitate action in any case as the current Constitution is in need of total review. The Ordinance does not require any Club approval by majority vote to become incorporated, however democracy should not be overlooked. Formal procedures will take three to four months to be completed by the Commission from the notification of intention to the issue of a certificate.

ADVANTAGES AND DISADVANTAGES

So that a clear view may be presented concerning any effect upon the Club, two contrasting viewpoints have been considered. The 'remain-as-we-are' position is compared to the 'become-incorporated' position as follows: Un - Incorporated

+ No requirement to pay any fees to the Government.
- A member may be sued and be caused to suffer the loss of valued assets - BMW, house, car, boat and so on.

car, boat and so on.

- cannot legally raise funds, apply for loans, or government grants.

- Club cannot take any legal action for anything.

- Club debts and liabilities can be satisfied from individuals.

- Club assets may be depleted by members demanding their share.

- Änother like Club may become incorporated with our name.

+ No substantial change to current organisation.

- As members of the public become more aware of their rights under the law, it is not difficult to imagine the vulnerability of the individual members.

Incorporated

Modest annual fees are payable to the Government.
 Club may be sued only to the limit of its assets.
 Can raise funds legally as Club sees fit subject to the Club Constitution and apply for loans or Government grants.

+ Club can take legal action.
+ Club debts and liabilities are not assumed by individual members.
+ All Club assets legally become that of the Club.

+ Club is guaranteed perpetual succession - it doesn't die.
- Need for some organisation review.
- Accounts audit report to Commission each year.

THE FUTURE

With the increase in awareness by the public of their individual rights under the law, it is no longer acceptable that incorporation be overlooked.

The Club needs to look to the future as well as to consider present activity plans, and objectives. With the 1984/85 Club year ending with more than a 100% increase in memberships to eighty three, it is likely that this number will not decrease significantly, if at all.

RECOMMENDATION

Any formal move to vote on whether to become incorporated is recommended for no earlier than the May 1985 general meeting. This would seem appropriate so that the many implications may be adquately considered by each member. Also revision of the Club's current Constitution should be ready by then.

CONCLUSION

It is felt that to be incorporated, the Club will be providing adequate protection of its own interests and restrict the liability which would otherwise apply under the law with respect to any loss of assets.

TOURING, Вов Rumsey

With the profusion of rallies scheduled for this year it seems that

there is far more scope for amazing feats of bad organisation.

The recent Australia Day Rally is one case that should never have occurred as it already had an established and successful format that didn't need changing. Let's hope that they can get it all together next year.

A new form of misorganisation, however, has been invented by the Gosford District M.R.A. In ten years of rallying I have never been unable to find a particular rally even with only a scant knowledge of its location. But what happens when one sets off, complete with entry form and attached map, and finds that the rally just isn't there!

"The Mangrove Creek Dam Rally, on the 9th and 10th of February", the entry form says, "Will be held on private property near Kulnara, north of Sydney". Further, "the property is off Kyola Road, about 6km before the dam, signs will be posted from Peats Ridge" (about 30km away), a map is attached. Clear enough directions you might say, except for the "6km before the dam" bit. You can't tell where that is without going to the dam and then back 6km. Anyway, there was no sign at Peats Ridge but there are signs indicating Mangrove Ck Dam, so that's no problem. At the intersection where Kyola Rd starts there is a tattered, wet cardboard sign with an arrow pointing straight up.

After searching the district for two hours, along with a couple of other lost souls, I eventually found another sign 12km past the intersection of another road and arrived at the rally site at 11pm in heavy drizzle,

about 20km away from the location detailed on the entry form.

The rally was in aid of the local branch of the 4B's organisation. Quite appropriate since I, along with several others, threatened to do some rearranging of the organisers' anatomies and offered to insert their rally badges into their fundamental orrifices. Membership of the Bent, Buckled Bikers' Brigade would have been very handy for them.

G/S Surgery

Sir - I thought I'd send in a few ideas I have tried on my R80 G/S. It's an excellent machine but needs some doctoring in a few areas.

Firstly, the 19.5 litre fuel tank is too small. This was cured by substituting a 24 litre job from an R100. The electrics which lurk under the tank need to be moved around and different brackets have to be welded to the frame to accommodate the larger tank but it's all fairly easy if you have access to an arc welder.

While the welder is out, brace up the subframe, from about half way along the seat to about 100 mm above the lower subframe mounting bolts with some tubing. This stopped my subframe from cracking.

The lump on the left-hand side which BMW calls a muffler fell apart, and as a replacement costs \$200, I made up my own. I turned the expansion chamber, which lives under the gearbox, upside down so the exhaust exits on the right. A slight re-angling of the pipe and the attachment of an aluminium muffler from a four-into-one gave me a good-looking system that exits low on the right-hand side. A bracket for the passenger's footpeg had to be welded onto the left side as well.

I did a quick cosmetic clean up, recovered the seat with leather, lashed out on a new blue paint job, and fitted a front guard from an XT500D.

All these modifications were relatively easy and cheap, especially the exhaust (which cost ten dollars) and as neither the headers nor the expansion chamber were altered, there has been no effect on the engine's power torque characteristics.
